# **Excellent General**Membership Meeting



The September 7<sup>th</sup> General Membership meeting was wellreceived and well attended. Our Second Vice President, Sebastian Aldana, had a great program. The speaker was City Councilman Randy Rowse who represents the Mesa Area.

Mr. Rowse began by indicating that he was very pleased with our new Chief of Police Lori Luhnow. He likes her experience and her style and he predicts that she will be a great asset to our community.

He indicated that financially, the city budget in on the mend, with a 16 to 17% increase this year in revenues from the Hotel Occupancy Tax. Furthermore, he predicts that once the new construction on State Street at "La Entrada" and the new Children's Museum by the train depot are completed they will further improve our city revenues. . He also announced that revenues from the city sales tax are suffering a downturn due to the closing of many major stores in

our community. This, however, is a trend being suffered nation-wide.

WATER: The good news is that the city was asked to reduce water usage by 25% and residents responded with a 35% decrease. Unfortunately, our water rates still increased due to our 5-year severe drought and the fact that our water source (Lake Cachuma) is at only 13% capacity. Complicating the problem is that as our as water tables reach lower and lower there is a great concern that chemicals and heavy metals will seep into our aquifers, many of which are found within the city. Our partial solution lies in our Desalination Plant which should go online late this fall or early winter He pointed out that the sea water will go through many filtrations and he expects that the water will not taste poorly. One of our contractors is an Israeli Company and they are highly experienced in desalination plants.

Questions from the audience: "What efforts is the city making to encourage people to save and use rainwater?" "Why is there still housing construction going on?" Mr. Rowse explained that statistics show that residence water-use amounts to only 2% of all water usage. The largest amount of water goes to residential landscaping. In California, 90% of water is used by agriculture.

It was apparent that our members were very pleased with the efforts of our program chair.



Volcanes Sewing School had their 3rd Generation graduating with honors. Sixteen out of 24 students graduated in July.

One of the students is a professional singer, and delighted us with a rendition of Whitney Houston's "Will Always Love You" and the traditional Mexican graduation song "Las Golondrinas", she also sang "Cielito Lindo", I guess she did it for the only gringo in the ceremony—Art Fumerton-.

They were all very proud of themselves, and thankful to their teachers Patricia Mora the Head Master, Alejandra Amigon, Patty's T.A., and Maria de Jesus Lopez, the cutting and pattern making teacher.

Bertha Medina head of production, was present to invite the new graduates to join the sewing workshop.

Out of the sixteen graduates, eight decided to stay in the workshop and join the team.

The purpose of our program is to empower women, by giving them a skill to provide supplemental income to their families, so their children can continue with higher education once they graduate from Junior High School; and – or to give them a position in the sewing workshop where they can earn a steady income to sustain their families.

Volcanes Sewing School and Volcanes Sewing Workshop are equal opportunity employers, we are inclusive to gender and age equality and welcome anyone who wants to learn how to sew and work in our workshop.

Our fourth class starts September 12 2016, and will last for four months.
