On behalf of the students, Teachers and the families of Colonia Volcanes and surrounding areas, I would like to thank you for your very generous donation of \$4,000 USD to our Volcanes Food Bank. We are using these funds to feed 100 families each week with a dispensa (food package) which feeds a family of four for three to four weeks.

The situation in Puerto Vallarta is very bleak. When the coronavirus appeared the tourists left earlier than normal. With the tourists went the jobs in the tourist industry and left just about every family in Volcanes and surrounding poor areas without any family income; no jobs, no food on the table. Without help these families will face hunger and serious health issues, inviting the virus into the community. To prevent the spread of COVID-19, the Santa Barbara City Council voted to require the public and employees to wear masks or face coverings in certain businesses. Implementation will begin on May 1, 2020. The following is a list of businesses affected:

- Pharmacies and drug stores;
- Grocery stores, farm and produce stands, supermarkets, convenience stores, warehouse stores, food banks, certified
 farmers' markets and other establishments engaged in the retail sale of canned food, dry goods, fresh fruits and vegetables, water, pet food and pet medication supply (but not grooming or training), fresh or frozen meats, fish, and poultry, or any other household consumer products (such as construction supplies, cleaning and personal care products);
- Organizations and businesses that provide food or other services to the public;
- Hardware and building supply stores, and nurseries;
- Laundromats, dry cleaners, and laundry service providers;
- Restaurants and retail food facilities that prepare and offer food to customers via pick up or drive-through;
- Taxis, ride sharing services, car rental companies, and other private transportation services. The Santa Barbara Metropolitan Transit District is encouraged to address driver and passenger safety through the use of face masks; and
- Hotels and motels, in publicly-accessible areas.

Businesses shall prohibit the entry of any person not wearing a face mask. A business may provide face masks to customers without charge or make them available for purchase. A business shall provide face masks without charge for the use of its workers.

Face masks may include cloth masks, scarves, bandanas or other face coverings over the mouth and nose of a person. The masks do not need to be N95 or surgical masks. Reusable face masks used by covered business workers must be washed and sanitized daily. Regarding: Update

As most of you know we have been working hard to reinvigorate the sister city organization here in Santa Barbara and initially focused on internal structure and membership, and moved to providing Irish cultural activities including a delegation visit to Ireland in 2018.

During the latter part of 2018 we attempted to connect with the sister city committee in Dingle to follow the footsteps of the other Santa Barbara sister cities in developing a rich connection that would include student—exchanges, along with business and cultural exchanges. To that end we reviewed the requirements for—sister city membership which included that each sister city be a defined legal entity, have an elected governing body, schedule meetings and publish meeting minutes, and establish a schedule of delegation visits to each sister city.

Prior to the delegation visit in 2018 (25 members visited Dublin, Kerry, and Dingle) we informed our contacts in Dingle of the process underway. During the visit in Dingle, we met with our contacts there and let them know that in order for the existing sister city arrangement to continue, they had to meet the requirements of Sister Cities National, as we had previously communicated.

When we returned to Santa Barbara the board discussed option going forward, and notified the Dingle contacts that we needed assurance of compliance with the sister city requirements in order to continue the current arrangement. We received a length reply which did not address meeting the requirements.

The board then decided to explore other options, and possibly arrange a sister city arrangement with another city in Ireland. However, Santa Barbara does not allow its sister cities to have an agreement with more than one sister city in a country. The required protocols were to:

- 1. Dissolve the existing sister city agreement
- 2. Establish a search committee to explore other options

The board felt that in order to move forward, we would make a request to the Santa Barbara Sister City Committee to initiate the two processes noted above.

- 1. The Committee initiated a request to the city council to dissolve the current sister city arrangement with Dingle
- 2. The Santa Barbara Sister City Committee established a search committee to explore the establishment of a new sister city arrangement with a city in Ireland, including Kinsale in County Cork. Committee members include:
 - Albe Dumalo
 - Georgia Gastouniotis
 - Margaret Saavedra
 - Tom McCool
 - Maureen McFadden

We are hopeful that the current membership and board will continue to develop a qualified sister city agreement with a compatible city in Ireland. We have received a notice of interest from the city of Kinsale in County Cork, and will consider them and any other qualified city in Ireland as potential sister cities. The search committee has the responsibility to follow sister city protocols to insure that the sister city in Ireland will be able to meet or exceed the wonderful participation exhibited by the other Santa Barbara sister cities.

As the process continues, we will update you on our progress.

Attached is the information for the first distribution using SB/PV Sister City and Rotary Club Santa Barbara North donation . The first \$90,000 pesos transfer funded two distributions , one May 7 and the other on May 13. The Expense Summary sheet shows the original \$90,000 and the expenses related to that donation. The detail expense shows how the funds were expended and the remaining balance in the account. It also shows the cost per dispensa. We originally estimated a per dispensa cost of about \$450 pesos each, for a family of four for three to four weeks. But by the time we got to your distributions, #6 and #7, we were buying in bulk in three or four locations and the price per dispensa has come down dramatically. It has allowed us to distribute more than the original estimate of 100 per week to 120 per week. The additional 40 families over two weeks were not on our original list but were found in very remote locations far from the center of Volcanes and others who heard of the food bank and came to ask for help. With the continued purchasing in quantity much lower prices than originally estimated and with several large donations of lentils, we will be ale to feed at least 500 families per month and extend the number of families fed with your contributions another week or two. We will know more after this week's distribution.
