

#### What is an Endowment Fund?

An endowment fund is a donation of money or property to a nonprofit organization, which uses the resulting investment income for a specific purpose. An endowment fund can also refer to the total of the nonprofit institution's investment assets, also known as its principal or corpus, which is meant to be used for operations or programs that are consistent with the wishes of the organization's mission. Endowments are a means to keep the principal amount intact while using the investment income for charitable efforts.
